Invest in Solutions to Align Health and Social Care

Support Workgroup Efforts to Co-Design Solutions

The Partnership's standing workgroups create solutions to align health and social care. Each workgroup requires financial support to advance efforts to:

- Develop co-designed resources and to promote Community Care Hubs (CCHs) as key partners in social care delivery system reform.
- Facilitate neutral, accessible communities of practice for health payers, health systems, providers, and community stakeholders to learn from cross-sector peers.
- Identify and help to scale existing best practices featuring successful health care and community partnerships across payment models.

Promote Health Equity Learning Efforts in Local Markets

The Partnership hosts a Health Equity Learning Collaborative (HELIC) comprising more than 40 teams in 22 states and Puerto Rico. Each team includes CBOs or CCHs, local or regional health plans, systems and providers, and individuals with lived experience to incorporate value-based payment principles to sustainably address social needs and promote health equity within their communities. The HELIC is seeking support to:

- Provide technical assistance and infrastructure support to local teams;
- Develop learning collaborative curriculum and promote promising practices;
- Evaluate the activities and outcomes of the HELIC to scale successful models.

Ensure the Partnership's Sustainability

The Partnership is a timely and high-impact stakeholder-driven collaborative. Participants from numerous sectors contribute their time and expertise to inform, develop, and review all Partnership activities. To ensure that these collaborative efforts thrive with full impact, the Partnership requires:
